### **Power Macintosh Made Simple**

MacUser's Stephen Somogyi gives a literate description of the inner workings of Apple's newest systems in **The PowerPC Macintosh Book**. The 256-page book provides all the information needed to decide whether to buy a Power Mac and helps owners understand more about how their system works. One of the chapters gives an introduction to microprocessor concepts and terminology, leading into a chapter on the PowerPC family of processors. The book also describes the Power Mac system hardware and software, including emulators.

Somogyi delivers a thorough description of the Power Macintosh with the added benefit of prose that is readable without an engineering degree. #### Explore the Hardware/Software Interface

Designing for optimal performance requires a close coupling between the hardware and the low-level software. This coupling is the topic of the sixth annual **ASPLOS**, the conference on Architectural Support for Programming Languages and Operating Systems, sponsored by the ACM. The conference, to be held October 4–7 in San Jose, features academic papers on topics such as operating system issues, performance measurement, compilers, and multiprocessor systems. On Tuesday, a workshop will be held on networks of workstations.

Conference cost is \$398 for ACM or IEEE members and \$558 for nonmembers. The workshop is priced separately at \$135, or \$189 for nonmembers. Student rates are available.
