logic diagram (positive logic)








SN54F30 . . . FK PACKAGE (TOP VIEW)

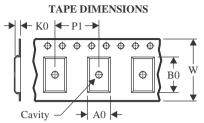
