#### IBM SolutionPac(TM) Personal Publishing System

The IBM SolutionPac Personal Publishing System hardware components are:

o an IBM Personal System/2(TM) Model 30 system unit

o an IBM Personal System/2 Monochrome Display Model 8503 or IBM Personal System/2 Color Display Model 8513

o an IBM Personal System/2 Mouse

o a new IBM Personal Pageprinter, a laser printer that has a print density of 300 dots per inch and,

o an IBM Personal Pageprinter Adapter.

The software components of the SolutionPac include:

o DOS 3.3

o Aldus PageMaker(R)

- o Microsoft(R) Windows, Microsoft Windows Paint and Microsoft Windows Write from Microsoft Corporation
- o The IBM Personal Pageprinter Adapter Program (a version of Adobe PostScript(R)).

The IBM SolutionPac Personal Publishing Option may be ordered to upgrade the IBM Personal Computer XT(TM) Model 286, Personal Computer AT(R) Models 99, 239, 319, and 339 and a Personal System/2 Model 30 to a Personal Publishing System. The PC XT and Personal Computer AT must be appropriately configured to include a minimum of 640KB of memory, a display with an Expanded Graphics Adapter (EGA) and a Microsoft Windows compatible mouse. The option SolutionPac contains:

o the IBM Personal Pageprinter Adapter Program

o Microsoft Windows, Microsoft Windows Paint and Microsoft Windows Write

o Aldus PageMaker.

(Note: DOS 3.3 must be installed on the processor.)

IBM SolutionPac Publishing System VM Edition requires an IBM 9370, 43XX, or 3090 with the VM/SP or VMIS Operating System; Graphics Display Data Manager (GDDM) Version 1 Release 4, or Version 2; the VM batch monitor; and Document Composition Facility (DCF) Release 3.1 with foreground environment feature.

Legal Profession Series requires an IBM Personal System/2 Model 30, 50 or 60 with one double-sided diskette drive and a 20MB fixed disk; 512KB of user memory; monochrome display; a Proprinter or Quietwriter; and DOS 3.3. It also operates with certain configurations of the IBM PC XT, PC XT Model 286, and Personal Computer AT with DOS 2.1 or higher.

## Doctor's Office Management

Doctor's Office Management SolutionPac requires an IBM Personal System/2 Model 30, 50 or 60 with 512KB of user memory (640KB for networking), one double-sided diskette drive, a hard disk, a color or monochrome display, printer and DOS 3.3. It will also operate on several configurations of the IBM PC XT and Personal Computer AT with DOS 3.1. The IBM Personal System/2 Model 30 and PC XT should only be used as stand-alone systems.
