The Optical Link Card (OLC) must only be connected to another OLC or a compatible laser product. About This Book

This book provides maintenance information that is specific to the 7012 Model G02 rack expansion units.

MAPs that are common to all systems are contained in *Diagnostic Information For Micro Channel Bus Systems*.

This book is used by the service technician for initial installation and to repair system failures. This book assumes that the service technician has had training on the *7012* Model G02 rack expansion units.

Adapters, Devices, and Cable Information, order number SA23-2764, contains reference information about adapters, devices, and cabling for the system units. This manual also contains the removal and replacement procedures for the logic boards on the disk drives. This manual provides the service representative pin-out lists and cabling information to use in isolating problems with customer cabling.

System Unit Safety Information, order number SA23-2652, contains translated versions of the danger and caution notices.

The 7015 Model R30, R40, and R50 CPU Enclosure Operator Guide, order number SA23-2742, provides information about the controls and features of the 7015 Model R30 CPU Enclosure.

The 7015 Model R30, R40, and R50 CPU Enclosure Installation and Service Guide, order number SA23-2743, provides maintenance information that is specific to the 7015 Model R30 CPU Enclosure. It also contains Maintenance Analysis Procedures (MAPs) that are not common to other systems.

Expansion Unit System Unit Locations

Description of the Disk Expansion Unit

The disk expansion unit is used to increase the number of media devices and/or disk drives.

All hardware components inside the disk expansion unit are accessible from the top side after the unit cover is removed.

From the top of the disk expansion unit, the following modules are accessible:

- Maximum of two 5.25-inch half height media devices (optional). Maximum of two 3.5-inch half height disk drive can be installed instead.
- The operator panel (required)
- The key mode switch (required)
- The ECB card (required)
- Maximum of two disk drives (optional) in the bottom tray
- Maximum of two disk drives (optional) in the upper tray
- One external cooling fan (required)
- The power supply (required).


Disk Expansion Unit SCSI Bus

The disk expansion unit is equipped with one internal SCSI bus. It is driven by a SCSI-2 single-ended controller through an external connection.


The SCSI bus features the following characteristics:

- SCSI-2 single-ended

Top View without Covers




Front View with Cover







Power Cables

Note: Refer to the Parts Information section of this publication to find the power cables that are available.

To avoid electrical shock, a power cable with a grounded attachment plug is provided. Use only properly grounded outlets.

Power cables used in the U.S.A. and Canada are listed by Underwriter's Laboratories (UL) and certified by the Canadian Standards Association (CSA). These power cords consist of:

- Electrical cables, Type SVT or SJT.

"For 230 V operation in the U.S.A. use a UL-listed cable set consisting of a minimum 18 AWG, Type SVT or SJT three-conductor cable a maximum of 15 feet in length, and a tandem blade, grounding type attachment plug rated at 15 A, 250 V."

Power cables used in other countries consist of the following:

- Electrical cables, type HD21.
- Attachment plugs approved by the appropriate testing organization for the specific countries where they are used.

Service Inspection Guide

Perform a service inspection on the system when:


- The system is inspected for a maintenance agreement.
- Service is requested and service has not recently been performed.
- An alterations and attachments review is performed.
- Changes have been made to the equipment that may affect the safe operation of the equipment.
- External devices that have their own power cable are added.

If the inspection indicates an unacceptable safety condition, the condition must be corrected before servicing the machine.

Note: The correction of any unsafe condition is the responsibility of the owner of the system.


Do the following:

- 1. Check the covers for sharp edges and for damage or alterations that expose the internal parts of the system unit.
- 2. Check the covers for proper fit to the system unit. They should be in place and secure with the screws tight.



- 3. Power down the system.
- 4. Set the power switch of the system unit to Off.
- 5. Unplug the power cord.

- 6. Remove the covers.
- 7. Check for alterations or attachments. Check for obvious safety hazards such as broken wires, sharp edges, or broken insulation.
- 8. Check the internal cables for damage.
- 9. Check for dirt, water, and any other contamination within the system unit.
- 10. Check the voltage label on the back of the system unit to ensure that it matches the voltage at the outlet.
- 11. Check the external power cable for damage.
- 12. With the external power cable connected to the system unit, check for 0.1 ohm or less resistance between the ground lug on the external power cable plug and a jack screw on the parallel port connector.



- 13. If the system unit passes the test in the previous step, install the covers.
- 14. Check each external device that has its own power cable:
 - a. For damage to the power cord.
 - b. For the correct grounded power cable.
 - c. With the external power cable connected to the device, check for 0.1 ohm or less resistance between the ground lug on the external power cable plug and the metal frame of the device.












Mounting Hardware For 7012 Model G02 Rack Expansion Drawer

Detail A - Front of Rail




Detail B - Rear of Rail




Step 4: Set the Tray on the Rails

Step 5: Remove Bezel from the Expansion Unit




Step 6: Set the Expansion Unit on the Tray

Set the expansion unit on the tray and push it to the rear until it is engaged by the metal lip on the cross member of the tray.


This unit weighs between 18 kg (39.7 pounds) and 32 kg (70.5 pounds). Two persons are required to safely move it. Using less than two persons to move it can result in injury.



Step 7: Secure The Expansion Unit

Secure the expansion unit to the front of the tray, using the supplied brackets and screws.


• Secure bezel safety tether with lower left screw.



Step 8: Replace Bezel on the Front of the Expansion Unit


Insert the positioning pins located on the inside of the bezel into the corresponding holes on the unit frame, and push the bezel toward the frame to snap the cover into place.

• Ensure that the bezel safety tether is secured to the left bracket (see Step 7).



Step 9: Connect the Adapter Cables

Connect the adapter cables between the base unit and the expansion unit.



Step 10: Checking Customer Outlets

Note: For a translation of the following notices, see System Unit Safety Information, Order Number SA23-2652.

CAUTION:

Do not touch the receptacle or the receptacle faceplate with anything other than your test probes before you have met the requirement in step 8.

1.. Have the customer locate and turn off the branch circuit CB (circuit breaker). (Attach tag S229-0237, which reads "Do Not Operate.")

Note: All measurements are made with the receptacle faceplate in its normal installed position.

- 2.. Some receptacles are enclosed in metal housings. On receptacles of this type, perform the following steps:
 - a. Check for less than 1 volt from the receptacle case to any grounded metal structure in the building, such as a raised floor metal structure, water pipe, building steel, or similar structure.
 - b. Check for less than 1 volt from receptacle ground pin to a grounded point in the building.

Note: If the receptacle case or faceplate is painted, be sure the probe tip penetrates the paint and makes good electrical contact with the metal.

- c. Check the resistance from ground pin of the receptacle to the receptacle case. Check resistance from ground pin to building ground. The reading should be less than 1.0 ohm, which indicates the presence of a continuous grounding conductor.
- 3.. If any of the three checks made in step 2 are not correct, ask the customer to remove the power from the branch circuit and make the wiring corrections; then check the receptacle again.

Note: Do not use the digital multimeter to measure grounding resistance.

- 4.. Check for infinite resistance between the ground pin of the receptacle and each of the phase pins. This is a check for a wiring short to ground or a wiring reversal.
- 5.. Check for infinite resistance between phase pins. This is a check for a wiring short.

CAUTION:

If the reading is other than infinity, do not proceed. Have the customer make necessary wiring corrections before continuing. Do not turn on the branch circuit CB until all the above steps are satisfactorily completed.

- 6.. Have the customer turn on the branch circuit CB. Measure for appropriate voltages between phases. If no voltage is present on the receptacle case or grounded pin, the receptacle is safe to touch.
- 7.. With an appropriate meter, verify that the voltage at the outlet is correct.
- 8.. Verify that the grounding impedance is correct by using the ECOS 1020, 1023, B7106, C7106, or an appropriately approved ground impedance tester.

Note: Do not use the 120-volt convenience outlets inside a machine to power the tester.

Step 11: Connect Power Cords


For the base unit and each expansion unit, connect the power cord to the rear of unit.

Note: For a translation of the following notices, see *System Unit Safety Information*.

CAUTION:

This product is equipped with a three-wire power cable and plug for the user's safety. Use this power cable in conjunction with a properly grounded electrical outlet to avoid electrical shock.

Attention: Do not plug the power cords into the power outlets yet.



Step 12: Set the Key Mode Switches and Plug in the Power Cords


Set the Base Unit Key Mode switch to Service (%), and each expansion unit Key Mode switch to Secure (a). Plug each expansion unit, the base unit, the (optional) terminal and any external device power cables into the outlets on the power distribution unit or other properly grounded electrical outlets. Then go to Step 13.

Attention: In this step the expansion unit key mode switch is set to the secure position. Leave this switch set to the secure position during normal operations.





If the AIX operating system has been installed, open the front door of the Expansion Unit, ensure that the key mode switch is set to the Secure postion ($^{\mathbf{A}}$) and press the power button. Then open the front door of the Base Unit, set the key mode switch to the Normal Position ($^{\mathbf{OK}}$) and press the power button (the power light below the power button is green when the system is on).





Chapter 3. Removal and Replacement Procedures

This chapter describes the removal and replacement procedures for all replaceable units unique to the system, and for other hardware components, such as the system unit covers. Any parts not listed here can be found in the removal and replacement procedures for the 7012 G Series systems.

Electrical Safety



Handling Static-Sensitive Devices

Attention: Adapters, planars, diskette drives, and disk drives are sensitive to static electricity discharge. These devices are wrapped in antistatic bags, as shown in this illustration, to prevent this damage.

Take the following precautions:


- Do not remove the device from the antistatic bag until you are ready to install the device in the system unit.
- If you have an antistatic wrist strap available, use it while handling the device.
- With the device still in its antistatic bag, touch it to a metal frame of the system.
- Grasp cards and boards by the edges. Hold drives by the frame. Avoid touching the solder joints or pins.
- If you need to lay the device down while it is out of the antistatic bag, lay it on the antistatic bag. Before you pick it up again, touch the antistatic bag and the metal frame of the system at the same time.
- Handle the devices carefully in order to prevent permanent damage.

Glossary: Special Terms Used in SystemGuard

BP (back plane). A panel located in the system unit and used to interconnect boards and devices.

BIST (built in self-test). Tests performed during the standby phase of the IPL process. The BIST phase comes ahead of the POST phase.

BUMP (bring-up microprocessor). A microprocessor which monitors the system, especially during the various IPL phases before AIX is loaded.

C1D card. See CPU card.

CPU card. A card containing the central processor unit (CPU). **CPU***n* is used to designate the *nth* CPU card. For example, CPU2 designates the second CPU card.

CPU (central processor unit). A primary processor for general calculations.

DIMM (dual in-line memory module).

Electronic Mode Switch (also known as **E_KEY**). A flag which enables the Key Mode Switch to be changed without actually moving the physical key.

EEPROM (electronically erasable programmable read-only memory). A type of non-volatile memory used to store firmware maintenance programs (like SSF) or boot programs.

FEPROM (flash electronically erasable programmable read-only memory). A type of non-volatile memory used to store firmware maintenance programs (like SystemGuard) or IPL programs.

E KEY. See Electronic Mode Switch.

ELM. See I/O planar

FFC (failing function code).

FRU (field replaceable unit).

I2C (inter integrated circuit). Special circuits used to connect devices to a high-speed bus called the I2C bus.

IOD. See I/O card.

I/O: Input /Output.

I/O card. A card which handles system I/O and directly connects to the system planar.

IPL (initial program load). The first phase of the system program loading.

JTAG (join test action group).

LCD (liquid crystal display). A low power display screen. There is a small LCD screen on the operator panel.

MCA (Micro Channel adapter). An adapter for the micro channel bus.

MCA Planar. A card with connectors for Micro Channel adapter cards.

MPE. A type of memory card.

MR2. A memory card with 8 8MB SIMMs.

MR4. A memory card with 8 32MB SIMMs.

MVR (multivoltage regulator). A power supply unit which regulates several voltage levels for various system parts (disks, CPUs, memory chips).

NFx. A type of memory card.

NVRAM (non volatile random access memory).

MP. The MCA planar located in the base unit.

MPB. See System planar.

MPe. The MCA planar located in the expansion unit.

PMA. See MP.

PME. See MPe.

POS (programmable option select). POS registers are used to specify MCA board options.

POST (power-on self-test). Tests performed during the initial phase of the program load process. The BIST phase comes ahead of the POST phase.

RDS (removable disk status). The status information for a removable disk drive (a disk drive which can be removed without turning the power off to the entire system).

ROS (read-only storage). Storage which does not support writing.

SCSI (small computer system interface). A standard bus interface used to connect peripherals such as disk drives or tape drives.

SIB (system interface board). The SIB is a system board which controls the power supply and the RS-485 interconnect bus.

SIMM (single in-line memory module).

SMP. Symmetric multiprocessor.

SRN (service request number).

SSBus (subsystem bus). A special bus used to interconnect the BUMP and some local resources such as the EEPROM, the flash EEPROM, and the non-volatile RAM.

SSF (system service facility). See SystemGuard.

SYSID (system identification). Identifies part of the EEPROM containing important data such as the system serial number, remote access rights, dial-out phone numbers, and other information.

SystemGuard.The firmware maintenance programs which run on the bring-up microprocessor (BUMP). It enables an operator to manage power supplies, check system hardware status, update various configuration parameters, investigate problems, and perform tests.

VPD (vital product data). Certain vital product data (VPD), such as the product serial number and status information, is stored on each board.
